OUT IN THE COMMUNITY

AH, DEAR ONES, WE LIVE in an epoch of increased specialization-to see this on the less-than-cosmic scale, have a look at the Services & Organizations column of this paper in which it would seem every human need or desire is, if not gratified, at least addressed; at least specialization need not always mean Balkanization, to use a currently near-obscene cant word. Further adducement of this, if any were required, is set forth in a proposition from the Lesbian and Gay Community Center that another group is forming there, this one for "Twenty-somethings" as an alternative to various varieties of high-decibel and liquorsoaked debauchery. So far, according to the prime mover and shaker in all of this, Scott Tierney-who has been in touch with the highly successful "Twenty-something" group in New York City and has taken it as his model-there are hopes of at least two meeting every month. The first of these is on Tuesday, January 10 at the Center (816 North Rampart). So perhaps specialization is not all that new...we could tell you a tale that happened to us, years before Stonewall, when we ventured into a gay bar for amputees in the West Thirties in New York, but we'll refrain. Of course, in those days, a word like "Twenty-something" would have been preceded by the adjective "Roaring."

AT ONE TIME, OF COURSE, IN OPERA, the contemporary was suitable only for the comic while only antiquity and myth and the medieval seemed to have acquired a sufficiently lustrous patina to inspire the tragic; with Verdi, this-as with so much else-changed, though Verdi's attempts to work actual historical events into his work led to censorship, charges of lése-majesté, and a good bit of libretto-shuffling (how else did *Un Ballo in Maschera* switch suddenly from the gay and giddy Swedish court of Gustavus III to dour Olde Puritan Days?) With verismo, things crept a little closer and so, finally, we end up with operas dealing with such things as the murder of Leon Klinghoffer during the hijacking of the Achille Lauro vu par Peter Sellars. It was only a matter of time, we suppose, before someone made an opera of the murder-cum-martyrdom of San Francisco City Supervisor Harvey Milk (as well as the city's Mayor, George Moscone) by the nutty and vengeful Dan White, a piece of human detritus if ever there were one. Stewart Wallace and Michael Korie are the composers, and we go on about this at length because the World Premiere of Harvey Milk (which sounds rather like the name of one of those Britten operas and, on a simple scale of grandeur, seems a bit pallid next to Boris Godunov or Adrianna Lecouvreur or even such one word wonders as Norma, Louise, Carmen, Sadko, Siegfried, Turandot, Arabella, ad nauseam)

is a production of the Houston Grand Opera, and will be staged January 21, 25, 28, and 31 and February 3 and 5 at the Wortham Center's Brown Theatre. Christopher Alden is the director and Ward Holmquist is conductor, and the singers are Robert Orth in the title role (a baritone), Gidon Saks as Moscone (a bass), and Ray Very as Dan White (a tenor), and Juliana Gondek sings the role of Dianne Feinstein—as Anna Russell says of the intergenerational romances in *The Ring*, "I'm not making this up, you know."

Those with a more than cursory interest in such historical matters and with the sufficiencies of leisure and means might want to attend. Tickets range from \$15 to \$75 and are available to those not in Houston by calling 1-800-828-ARTS. Harvey Milk was, by the by, commissioned by Drs. Dennis and Susan Carlyle.



OREGON CITIZENS ALLIANCE CHIEF: THIRD TIME'S THE CHARM

SALEM, Ore. (AP)—The attorney general's office has rebuffed a bid by the loathsome Lou Mabon and his Oregon Citizens Alliance to put its latest anti-gay-rights measure on the May 1996 primary ballot instead of the November ballot. Though statewide citizen initiatives have always gone on the November ballot, the OCA said it wants to place its new plan on the May ballot to avoid competition from other measures in the fall election.

Attorney General Ted Kulongoski's office said December 16 that the state constitution spells out that votes on initiatives measures are to be held in the general election, unless the Legislature specifies otherwise.

OCA Chairman Lon Mabon said his group might challenge that interpretation in court. To be safe, however, the group has filed a new measure for the November 1996 ballot as well, he said. The OCA's latest attempt to enact a statewide anti-gay-rights policy was rejected by voters in the Nov. 8 election. Δ

STUDY SUGGESTS NEW HERPES VIRUS MAY CAUSE KAPOSI'S SARCOMA

WASHINGTON (AP)—A deadly cancer that strikes more than a fourth of all homosexual men with AIDS may be related to a herpes virus, according to researchers who report today on discovery of genetic evidence of the virus. In a study published in the journal *Science*, researchers led by a husband-and-wife team at Columbia University report that unique DNA sequences, or fragments of genes, were isolated from tissues of Kaposi's sarcoma lesions taken from AIDS patients and that the gene material may be from a previously unknown human herpes virus.

"The DNA sequences we found contain portions of at least three different genes that are unique to herpes virus," said Dr. Yuan Chang of the Columbia University College of Physicians and Surgeons. "The evidence strongly suggests that these DNA sequences belong to a new herpes sequence, but additional tests are needed to confirm it." Finding the viral gene sequences in nearly all of the Kaposi's lesions tested raises the intriguing possibility that the same virus is the cause, or at least a contributor, to the cancer, said Chang. But she emphasized this is only speculation.

Proof that a virus causes Kaposi's sarcoma could lead to developing a diagnostic test to find people susceptible to the disease and perhaps to a drug that would kill the virus and thus prevent the cancer.

Chang's husband, Dr. Patrick Moore of the Columbia University School of Public Health, said Kaposi's sarcoma, or KS, was a rare cancer, usually seen only in elderly men of eastern Mediterranean ancestry, until the AIDS epidemic. Since then, KS is found in 25 percent to 50 percent of all gay men infected with human immunodeficiency virus, or HIV, which causes AIDS. Moore said that the classic KS is a slowly developing disease of the skin but that in AIDS patients the cancer can spread throughout the body and is "very serious and very aggressive."

Laboratories all over the world have been trying to determine if KS is caused by some

infectious agent. Other viruses or bacteria have been suggested in the past, but were never confirmed. "It's really good work and it could be a substantial advance," Dr. Robert Gallo of the National Institutes of Health said in Science. "But I have major questions." Gallo and other researchers suggest more proof is needed of the precise role of virus in KS.

Chang and Moore said they plan to test for the virus in tissue from patients with the classic KS not associated with AIDS. If the virus is found there, it would support the suggestion that the virus causes KS. There are seven human herpes virus, and all are troublesome.

Moore said that viral gene sequences isolated so far show that the new virus is most closely related to Epstein-Barr, a herpes-type virus that causes mononucleosis and has been associated with some cancers, and to samimiri, a herpes virus that causes cancer in monkeys. Chang, Moore and their colleagues found the virus gene sequences in 25 of 27 tissues tested from AIDS-related KS lesions. The sequences were found in six of 39 non-cancerous specimens from patients who had AIDs. In 85 people with neither AIDS nor KS, the gene sequences were not found. Δ

NEBRASKA CLUB OWNER AGREES TO REMOVE CONTROVERSIAL ART EXHIBIT


OMAHA, Neb. (AP) –The owner of a nightclub has agreed to remove a controversial display of gay art while a judge decides whether the pictures are pornographic. Omaha City Prosecutor Martin Conboy said he agreed on December 15 not to file charges against Terry Tippit, the owner of the Run club, after deciding that the issue would best be decided through a civil proceeding. "From our perspective, they've agreed to stop the display," he said. "It's as much as we can ask, and we'll get the same resolution because we'll get an issuance of opinion by a judge."

Police seized three pictures December 13 on display in the basement of the nightclub. Tippit said the pictures are part of a 22-piece art collection done by gay artists from San Francisco. "If they consider this bad, I'd say they need to look at the floor of the Capitol building and the Joslyn (Art Museum). There's some pretty lewd stuff in those places," Tippit said.


Tippit's attorney, Jeffery Silver, plans to ask a district judge next week to decide whether the pictures in question are pornographic or obscene under state law. The agreement means that Tippit avoids a criminal proceeding, Silver said. "Ultimately, it's a question of what scenario a court will determine this under," Silver said. "Now it will be civil proceeding, so that eliminates any criminal elements."

Conboy said he had planned to file a misdemeanor charge of exhibiting pornography against Tippit. The decision followed an investigation in which police officers confiscated three pieces. The works contain nudity and some depict men performing sexual acts. "There is no hard and fast standard or special guideline in these cases," Conboy said. "But what I saw, by law, would not be acceptable for public display." A

CHIEF RABBINATE COURT CRITICIZES RECOGNITION OF GAY COUPLES

JERUSALEM (AP)—An Israeli Supreme Court ruling recognizing the rights of gay couples will destroy the fabric of Jewish life, Israel's Chief Rabbinate said on December 13. Moshe Friedman, spokesman for the nation's top religious authority, said the ruling ignores the principles of the Torah, or Jewish Bible. "This decision provides a dangerous opening toward justifying a way of life defined in the Torah as an abomination," Friedman said in a statement. "The ruling uproots the central place of family in Israel and undermines moralistic Jewish character as it is expressed in the Torah."

The high court ruled Oct. 30 that the national airline El Al must grant the boyfriend of a flight attendant the same benefits granted to spouses of other employees. The rabbinate, made up of the chief rabbis of the Ashkenazi and Sephardi Orthodox communities, called for Israel's parliament to pass a bill using Jewish law to define a couple. Leaders of the Reform Jewish movement accused the rabbinate of trying to impose its Orthodox standards on a largely secular public. "The Chief Rabbinate has a monopoly over Jewish life in Israel and we don't agree with that," said Amir Shacham of the Israel Religious Action Center, a Reform group. Shacham said Reform rabbis would not perform a homosexual wedding ceremony because of religious principle, but the issue at hand was one of civil rights. Δ

CALIFORNIA COPS SAY MURDER VICTIM WAS A MAN

CONCORD, Calif. (AP)-Police investigating the death of a transvestite who was married to a Washington state Navy sailor were unsure whether the victim's sexuality was a factor in the killing.

"It's certainly possible, but we just don't know," police spokesman Joe Kreins said December 12. The 28-year-old transvestite who went by the name Terrie Ladwig was found strangled in the couple's apartment on Dec. 2. Ladwig married Navy Petty Officer Steven Ladwig last summer in Reno. The couple had dated about four months before Steven Ladwig discovered that his partner was a man. "I was kind of confused, but I wasn't upset," said Steven Ladwig, 25. "I consider her full female. I'm not gay. I don't feel that way. It wasn't really a sexual relation. We were friends. I was lonely, she was lonely. Mostly we enjoyed each other's company."

Steven Ladwig found his partner's body in their apartment after returning from a tour of duty aboard the USS Parche. He is not a suspect in the killing, Kreins said. Terrie Ladwig, also known as Larry Earl Thompson, intended to have surgery to become a transsexual, police said. Military officials were investigating the incident, including Steven Ladwig's sexuality, but declined to say whether he faced discipline, said Navy spokesman Michael Pascoe.

The investigation could take some time because it was unclear whether Steven Ladwig, who has said he is not gay, falls under the military's "don't ask, don't tell" policy regarding gay soldiers, Pascoe said. Steven Ladwig is stationed in Bangor, Wash. Terri Ladwig, a nurse, was planning to move to. Washington state later this month to be closer to the base. Police do not have a motive or any suspects in the murder. Δ

MASSACHUSETTS TEEN-AGERS COMPLAIN GAY RIGHTS LAW IGNORED AT THEIR SCHOOLS

BOSTON (AP)—At 16, Kate MacLeod says she already has been hounded out of one school by classmates who branded her "a dyke and a lesbo" because she dressed a little differently and spoke out for gay rights. That was only junior high, too, and before she had told anyone she was bisexual. In between, there were occasional thoughts of suicide but mostly pain. "Every time I hear those hateful words, I hurt," MacLeod, a sophomore at Duxbury Junior-Senior High School, told the Governor's Commission on Gay and Lesbian Youth on December 12. A year after Massachusetts enacted the nation's first law protecting the civil rights of homosexual teen-agers in public schools, students say gay bashing continues unabated in classrooms and hallways across the state.

What's worse, students and state officials say, is some principals are doing little if anything to enforce the law protecting their gay and lesbian pupils.

"Until now, we have given schools time to voluntarily follow the law," said David LaFountaine, chairman of the commission. "There seems to be a lower standard for respecting gay student rights than for other civil rights of students." LaFountaine said testimony from some of the more than 250 students, parents and educators at the hearing would be included in a report to Gov. William Weld on how to close gaps in enforcing the law.

Since Weld signed the protections for gay students into law last year, the number of gay-straight high school support groups around Massachusetts has jumped from just five to 35. But the increased visibility of the gay and lesbian groups has drawn both the ridicule of classmates and attempts in by some school officials to disband the organizations, LaFountaine said.

Alan Safran, a spokesman for the Massachusetts Department of Education, said he was unaware of any instances where administrators or teachers were resisting the law meant to make schools safe places for gay and lesbian students to learn. C.J. Doyle, of the Catholic League for Religious and Civil Rights, blasted the law as "a weapon in the hands of homosexual militants to censor, silence, and punish critics of homosexual behavior." Doyle said the law limits free speech, citing the case of a teacher at Boston Latin who was reprimanded for "the thought crime of expressing his moral beliefs about homosexuality."

Meanwhile, state education officials and gay activists want to start requiring teachers to be trained on how to help gay and lesbian students cope with some of their problems. The program, believed to be the first of its kind in the nation, is part of a larger campaign to improve the lot of gay students at public schools.

Activists say many teen-agers feel isolated in school and suffer intense emotional pain as they come to grips with being homosexual. A federal study has suggested that gay teens are at a much greater risk of attempting suicide than their heterosexual peers. But it takes more than just a handful of programs that few students even know exist to combat homophobia, said Jennifer Adleman, a senior at Arlington High who founded the school's Gay Straight Alliance earlier this year. "Just because a task force exists and just because 80 kids go to see the movie *Philadelphia* doesn't mean the school is a safe place to be gay or bisexual," she said. Δ

SEATTLE BISHOP SAYS NIXING GAY WEDDING GRIEVED HIM

SEATTLE (AP)-An Episcopal bishop says it was extremely painful for him to stop a gay wedding that was to be held at a Seattle church. In a letter read to parishioners at St. Mark's Cathedral on December 11, the Rt. Rev. Vincent Warner said he couldn't allow the ceremony because the church has not taken a position on same-sex unions. "As a person who has all my life stood with those who are marginalized by the church and society, it grieves me deeply that I am the person who says no," Warner said in his letter. "And I ache for the couple who only asked that their care for one another, their covenant, be witnessed and blessed by the

Thom Monnahan, 39, and Jim Black, 52, had planned a commitment ceremony at the Capitol Hill church that afternoon and had invited hundreds of guests from as far as England and Vietnam. But Warner last week told the Very Rev. Frederick Northup, dean of St. Mark's Cathedral, he couldn't perform the blessing of the same-sex union.

Northup offered to preside over the ceremony anyway, but the couple called it off. They said a union not blessed by the church would not open the door for other gay couples. Warner said the Episcopal church's general convention last August decided that before same-sex unions would be blessed, a theological basis for a liturgy would be developed. He said it would be presented to the next general convention in 1997.

But Warner, bishop of the Diocese of Olympia of the Episcopal Church, added that he would start a dialogue on the issue between now and the church's next general convention. A letter from Monnahan and Black also was read to the congregation. In it, the couple apologized for any inconvenience the issue has caused and thanked parishioners for their support. In his sermon, Northup said he was both ashamed and proud of the church over the issue. "In the dialogue in these coming months, we must point out the hypocrisy of the church," he said. "Either we accept people or we don't." A

SANTA WITH AIDS REACTIVATES SUIT AGAINST MACY'S

NEW YORK (AP)-Mark Woodley's Santa costume hangs in his closet like an old tuxedo.

He put it on only once this season. Five years ago, when he was Macy's grand old elf, children opened their hearts to him. But then he got the virus that causes AIDS. The world's largest department store refused to rehire him. And he filed a lawsuit against Macy's (which has always preened re its holiday 'spirit', cf. Miracle On 34th Street in any of its various incarnations and that horrid Thanksgiving parade) saying it had discriminated against him because he was HIV-positive. The suit lay dormant, however, after Macy's bankruptcy in

During the next three years, Woodley kept busy as an architect and played Santa for private parties, mostly for children with AIDS. But he still dreamed of getting back his job at Macy's. Now, with the store's acquisition by Federated Department Stores Inc. and its emergence from Chapter 11, Woodley and his lawyers are dusting off his lawsuit and pushing ahead for a day in court. "Basically, after waiting three years to get my day in court, we are going forward to do that," Woodley, 45, said December 9. Earlier that week, his lawyer, Elizabeth Koob, sent a letter to Macy's lawyers informing them that he was proceeding with his

Woodley is seeking more than \$3 million in damages, as well as the opportunity to play Macy's Santa again. He also said he filed the suit to educate people about AIDS. "It was a personal thing that has an important principle behind it," he said. "You can't get AIDS from Santa Claus. You can't get AIDS by sitting of Santa's lap. If it was transmitted that easily, everyone in the country would have it. The fear that was behind Macy's decision not to rehire me is a fear that I think needs to be addressed."

Besides, he said, "I was one of the best Santas they had when I was there. I really did the job well. ... I believed in it, in the magic of Santa Claus.

Macy's spokeswoman, Christine Carter, said the store would not comment on the suit, but added, "We absolutely do not discriminate. We never have discriminated. And we are an equal opportunity employer." Macy's officials have said in the past that the year Woodley was not rehired, he was offered a job supervising Santas at more pay. And they noted the store has give thousands of dollars to AIDS causes

Macy's also said it was worried that the drug Prozac, which Woodley was taking for


depression, would cause him to have sharp mood swings. He had written on his employment application that he was taking AZT, an AIDS medication, as well as Prozac.

Woodley has been diagnosed as having AIDS, but no infections have set in, he says. He describes his health as "pretty good." He recalled that in 1989 he went to Macy's to play Santa help him get over the death of 'What better way to reaffirm

the wishes of children with the AIDS virus at the State University Health Science Center in Brooklyn, he felt his own life was reaffirmed. The children, he said, reminded him of how important it is to live in the moment. "They don't let (AIDS) stop them," he said. "They go full tilt." Δ

SHREVEPORT THIEF BITES EMPLOYEE, SAYS HE HAS AIDS

SHREVEPORT, La. (AP)—A man who tried to steal meet from a local supermarket bit an employee who chased him down and shouted that he had AIDS, police said. The 25-year-old would-be thief, whose identity was withheld, remained in jail without bond December 13 on a charge of intentional exposure to AIDS virus. If convicted, the felony charge carries a maximum fine of up to \$5,000 and a prison sentence of up to \$10 years.

The man also was booked on misdemeanor charges of simple theft, simple property damage, disturbing the peace, resisting an officer and contempt of court, a jail official said. Police said the man tried to steal meat from a Kroger supermarket about 9 p.m. on the preceding evening. When confronted by an employee, he reportedly ran and dropped the meat inside the store before fleeing on a bike.

The employee, who asked not to be identified, jumped in his car and gave chase and caught the man, who bit one of his fingers as the

two fought during an argument about the attempted theft, police said. Shreveport police Detective Tom Oster said the suspect allegedly yelled to the employee that he had AIDS before biting him. However, at the jail, the would-be thief told police he did not have the virus, Oster said.

"He said he just wanted to scare the guy and hurt him," Oster said. Police often encounter similar incidents. "They (people in custody) spit at and scratch us all the time. And then they like to tell us, `I have AIDS,'' Oster said. "It's the big thing for them to do now. They want to slow you down from making the arrest." Δ

STUDY SHOWS GIRLS OFTEN FORGET ABUSE

DURHAM, N.H. (AP) –Women who were sexually abused as children often have no memory of it, according to a recent study.

University of New Hampshire sociology professor Linda Meyers Williams and her colleagues interviewed 129 women, who as children had gone to the hospital after being sexually abused during the 1970s. Seventeen years later, 38 percent had no memory of the abuse, which had been documented in hospital records, she found.

Williams said the results were surprising. Although some of these women may have

decided not to tell interviewers about the abuse, other findings suggest they didn't remember. Memory also is dependent upon how close the women were to their abusers, she said. The study suggested some women did not remember when a family member abused them because the women felt betrayed or lost trust in that person and found the experience painful. Women who were molested by strangers were more likely to recall the abuse than those who were abused by someone they knew, she added.

Williams recently published an article about her research in the Journal of Consulting and Clinical Psychology. The women were comfortable with interviewers and spoke of other very personal matters, such as other sexual abuse and intimate details of their sexual histories, she wrote. She concluded that makes it unlikely they would have been embarrassed to discuss the abuse that led to hospital visits.

Of the women who remembered being abused, 68 percent told interviewers about other assaults they experienced as children. Womenwho didn't remember the specific incident of abuse were likely to have suffered it at a younger age than those who remembered, Williams said.

Williams also believed very young girls may have lacked the mental development to remember. Sixteen percent of the women who did remember the abuse reported periods when they could not remember it, she noted. Some women recalled remembering the abuse after watching TV shows which dealt with topics of sexual abuse. Many of the women who remembered the abuse described the incident much as hospital records depict it. "Having a time period with no memory of abuse doesn't necessarily indicate the person wasn't abused," she said. Recovered memories should not be discounted, but not all recovered memories should be believed immediately, Williams commented. A

CAMBODIAN NEWSPAPERS WARNED ABOUT SEXY MATERIAL

PHNOM PENH, Cambodia
(AP)-Information Minister Ieng Mouly
threatened on December 16 to shut down local
publications if they continue publishing "sexy
stories and pictures." Mouly said he would order
five newspapers closed the following week if
they did not stop printing salacious material. He

did not name the newspapers. Cambodia's free press has been under pressure from the government, which came to office after a United Nations-supervised election last year. A draft press law to be considered by the national assembly would heavily penalize publications which are found to have slandered the country's king or published material deemed libelous. Local and foreign press associations have criticized the law's guidelines as unfair and unreasonable. (This is the result of "free", i.e., supervised-by-the-West, elections?)

Pressure has already been applied on local journalists, who have been attacked, and have been threatened by officials. Three journalists have been murdered or died in mysterious circumstances this year. Ieng Mouly claimed the publication of sexy material-primarily photos of women garbed in bathing suits and other attire which is revealing by local standards-"strongly affects the good traditions of Cambodia, and, especially discredits Khmer (Cambodian) ladies' prestige."

However, Khmer Journalist Association president Pin Samkhon said he opposes shutting down newspapers because of their sexy content. "I don't support the sexy publications, but it is not a solution to close newspapers because of it," Samkhon told The Associated Press.

The association wants the information ministry to issue a directive in advance to guide journalists before taking peremptory action. Meanwhile, the U.N. Center for Human Rights here and UNESCO, the U.N. cultural agency, plan to train Cambodian journalists about ethics and defamation.

The goal is to help Cambodian journalists become more professional, said a statement from UNESCO. The first week-long seminar on ethics will begin Dec. 26, and more seminars are planned for next year. Δ


BALTIMORE MAYOR SIGNS REGULATIONS FOR CITY'S RED LIGHT DISTRICT

BALTIMORE (AP)-Patrons of the city's infamous red light district will be walking into city-licensed businesses when they frequent The Block's tawdry nightclubs and peep shows from now on. On December 15, Mayor Kurt L. Schmoke (a humane sort of guy, already on the right side vis-a-vis drug legalization) signed into law legislation requiring licensing of the district's risqué establishments, while also expressing his hope they would be gone within 10 years. "Our biggest problem is we just don't have the bucks to just come in and buy up all the businesses," Schmoke said. "What we're trying to do in the short run, the next three to five years, is just contain it, clean it up and regulate the activities so that we don't have abuses of law down there," Schmoke said.

The mayor said he hoped development pressures around the district would eventually force the bars and nightclubs out. City officials are now promoting plans to develop the old Brokerage and Fishmarket complexes east of The Block into a children's center and museum.

The bill also bans sidewalk barkers who try to draw customers into the clubs and forbids blinking neon signs or posters of an adult nature. State Police conducted a high-profile raid on The Block last January, but half of the resulting criminal cases were later dropped because of weak evidence, poorly executed search warrants and police misconduct. The next Storyville? Δ

ELECTION RESULTS II

he November elections, along with changes in national organizations, require that careful thought be given to assessing what the effects will be for lesbians and gay men, and what elections should now be taken. It would appear that the elections have caused upheavals in the way the US government is going to do business, as well as in some aspects of its guiding philosophy. Or so one might presume.

The truth is, however, that no one really knows what's going to happen. It is presumptuous—if not downright folly—to make pompous pronouncements about who is going to do what and what the results will be. Although this is always a wise caution, it's particularly relevant regarding these current political circumstances. One reason is because there is no precedent in the short experience of national political lesbian and gay organizing. Even throughout the Reagan and Bush presidencies (1980-92), and the first six years of that period when Republicans controlled the Senate, Democrats maintained large majorities in the House.

Another reason is that, more so than ever before, political tides can ebb and flow very quickly-remember that President Bush's job approval in 1991 approached an unprecedented 90 percent, and a year later he was defeated by one of the most humiliating margins that any incumbent President has ever suffered.

So let's avoid pronouncements. Instead, let's list some things that *could* happen and some things that bear careful watching.

irst, the Presidency of Bill Clinton. Although some of the shriller gay voices on both the left and right fringes still don't seem to understand, Clinton has been the best friend that lesbians and gay men have ever had in the White House. Unless someone better becomes a viable candidate, he's the best we've got. It appears that neither the Republicans nor the Democrats will nominate anyone in 1996 who would be better on lesbian/gay issues: Neither a Jesse Jackson nor a William Weld (the Republican Governor of Massachusetts) is thought to have a chance at gaining their respective party's nomination. So it stands to reason that a weakened Clinton Presidency is not in the best interests of lesbians and gay

Judging from his recent "middle-class tax cut" speech and other statements, it appears that Clinton is going to try to move to a more centrist position on economic issues. But close attention should be paid to whether he also distances himself from his previously progressive stance on social issues.

Second, there is the Congress. The election has obviously produced more conservative majorities in both houses, groups less friendly to the legislative matters important to gay people. But other than the total numbers, there are some particularly sensitive aspects of the Congressional process that cause concern.

One of these is the matter of committee chairs. They are very powerful people who determine to a large extent what legislation even gets considered. Some very friendly Democratic chairs have been replaced by some very hostile Republicans.

For example, Joseph Biden of Delaware, who had an 80 percent positive voting record according to the Human Rights Campaign Fund, has been replaced by Orrin Hatch of Utah, a consistently vocal opponent of lesbian and gay issues, who has a zero percent positive HRCF record. One wonders if someone like Ginger Berrigan, a great good friend of the lesbian and gay community in New Orleans, could survive confirmation from a Hatch committee. Or, also, whether Clinton would nominate her today; or, indeed, if she-and other progressive judicial appointees now-would be willing to subject themselves to the sort of attacks that might occur during the confirmation process. Remember the Clarence Thomas-Anita Hill mess? Well, that's the Hatch-Strom Thurmond gang who will now be running the show in the Judiciary Committee.

nother Senate committee to watch is Labor and Human Resources. Ted Kennedy was the previous chair, and because of his strong support, it was this committee that a months ago held the first Senate hearing ever on a lesbian and gay civil rights bill, the Employment Non-Discrimination Act (ENDA). Kennedy was one of the thirty-two Senate co-sponsors of ENDA this year. Now he has been replaced by Nancy Kassebaum of Kansas-not a cosponsor-who has a zero percent positive voting record on the gay and AIDS bills that the HRCF monitored. And it was Kassebaum who, herself, tried to exclude sexual orientation from the non-discriminatory language in health legislation this year. It is going to be very difficult to move ENDA forward unless Kassebaum becomes supportive. ENDA is the whole centerpiece of national lesbian and gay civil rights policy. Watch this closely.

Another Senate Committee to monitor is the Foreign Relations Committee, now to be chaired by right-wing demagogue Jesse Helms of North Carolina. He will have the

opportunity to affect aspects of immigration and international AIDS issues, and it is hard to believe he won't use his new chairmanship for maximum destructiveness. This committee also handles the confirmation of diplomatic appointments, so Washington insiders are paying close attention to the upcoming confirmation hearings on a gay man who has already been named by Clinton to an ambassadorship. As mentioned in the Judiciary Committee consideration, it will be interesting to see if the man now withdraws his name from nomination—or if the President withdraws it.

Asecond part of the political process that could be greatly affected by Republican majorities in both houses of Congress is what happens now in House-Senate conference committees. These are the committees appointed to resolve differences in the language of bills passed in each of the two houses. It is in conference committees where Democratic majorities have quietly and successfully removed some of the most virulent antigay aspects of legislation. A recent example of this was the conference committee deletion of Jesse Helms' amendment to the

Education Act. Helms' amendment would have eliminated counseling programs for lesbian and gay teens, suicide prevention programs, and AIDS information programs for teenagers. Usually these House-Senate conference committees work quietly and don't receive much attention. Now, especially, they demand careful attention.

All in all, the most important thing to watch may very well be how the Republicans handle the explosive social issues such as lesbian and gay civil rights. abortion, school prayer, AIDS, and gun control. If the Republicans are very smart, they will convince their Christian Coalition and National Rifle Association colleagues to keep quiet for the next two years in the hope that, in 1996, the public will keep majorities in the Senate and the House, and will also elect a Republican President. If that happens, they will then control all three branches of the Federal government: The White House, Congress, and the Supreme Court. Then it would be far easier for the radical right to get what it wants.

It bears watching. Δ



I like that. Δ





IN THE PUBLIC EYE

IFE-STYLES OF THE RICH AND HEINOUS: We finally got around to reading the short book, Nicole Brown Simpson, by Faye Resnick, telling her version of the Simpson affair. It is, as we expected, self serving and it really doesn't tell us much about the Simpsons that we didn't already pick up in the media. Fave seems to be one of those free spirits so common in Southern California. (She is only free if she can't find someone to pay for it.) Kind of a latter day Holly Golightly, except that the original Holly was a male prostitute that Truman Capote picked up on the street; although the majority of that novel was fiction, the one thing that remained was the title: the poor hustler was so ignorant that he thought Tiffany's was a fine restaurant, thus the request for breakfast there. Needless to say the notoriously stingy Capote didn't take him to breakfast there; the kid was lucky if Truman took him to the Automat

But Faye Resnick was probably one step above the streets. LA is filled with young boys and girls who work as waiters, etc. and are ready to do anything to almost anything to latch onto a real moneymaker. If one can hang on for a couple of marriages/serious affairs, squirrel away a few bucks (\$100K) and not become addicted to a costly drug, he or she should be able to open a small business, utilize the friends and sophistication acquired along the way, and prosper.

Such appears to have been the way in which Faye got ahead, but when she and Nicole Brown were going to open a coffee shop, poor old Faye was apparently down to her last twenty thousand, and Nicole's unfortunate demise was a godsend.

How much she actually knew about the Simpsons is putative, but she had some pictures of herself with them and their closest friends, thus qualifying her to write the book. (A word to the wise: hang onto those old photos of yourself with a celebrity; You never know when they'll come in handy.)

Faye does take the opportunity to dump on the ubiquitous Kato Kaelin, some time jester to the Simpson court. The whole affair does in some vague way resemble some Byzantine court with the sycophantic hangers-on being used as go-betweens by the principals, something like Procopius Secret History but with snazzy, costly cars and drugs added. Kato is apparently resented by Faye (note the contrived spelling, always the hallmark of the parvenu), no doubt because he was at one time more central to the action than Faye: He was at first a supernumerary in the household of Nicole before being lured away by OJ, with promises of more

and bigger dick, or more and better cocaine.

Faye does, however, in the only bombshell in the book, let us know that she and Nicole tasted the delights of homosex (female variety). According to Faye, it just happened. We wonder if it also just happened to OJ and (as they would say in Hollywood) his very dear friend, Bruce Jenner, closet homo, quondam Olympian decathlete, and onetime boxboy for Wheaties, the Breakfast of Champions.

(We remember the first time we met Bruce at a party: when we were introduced, we inquired was he not a track star, and he shyly said yes, whereupon we said, grasping the basket, "Take a lap around this." We were thereupon shunned and ultimately asked to leave the party. Closet cases have no sense of humor)

ORE LIVES OF THE RICH AND HEINOUS: The current New Yorker has an interesting article about Tennessee Williams and the late Lady Maria St Just. Entitled "The Lady and Tennessee", it was written by John Lahr, the son of Bert Lahr (the Cowardly Lion of The Wizard of Oz, and before that a low comic of some repute) and the author of Prick Up Your Ears, the anagramatically-titled biography of Joe Orton, homo playwright of the sixties. More about Lahr later.

Maria St Just was a high class Faye Resnick, a woman who by means of obsequiousness and guile rode on the coattails of the rich, the famous and even the noble (her husband, the deranged Lord Peter St Just left her nothing, but he left a considerable fortune to their daughters—he wasn't that deranged). Because she was the daughter of a petty bourgeois Russian-English couple, she reinvented (the current euphemism for lied) herself into the position of a displaced Russian aristocrat.

Shortly before the end of his life, Tennessee, in a casually made will, named her a co-trustee of the trust, derived from the income generated by his writings, benefitting the unfortunate Rose Williams, his lobotomized sister. Maria St. Just used this position to become, in effect, his literary executor, which was certainly not his intention. The trust, however, owned the rights to his most important works, and Maria St. Just capriciously used this wedge to deny production rights to person(s) who annoyed her, becoming a nauseating and ostentatiously presumptuous bully about Williams' literary style and the motives for both his characters and his creation of them.

But now more about the author, John Lahr. Any Anglophile should know better

than to refer to Maria St. Just as Lady Maria St. Just. Properly she should be called Lady Peter St. Just, since she was not herself a member of the aristocracy, just as the non-aristocratic wife of Prince Michael of Kent is known as Princess Michael of Kent.

This of course is not his worst transgression: Lahr, a noted closet case, neglects to mention what Maria's real role in Tennessee's life was. She and some of her friends liked to refer to her as the inspiration for Maggie in Cat on a Hot Tin Roof, but she was no Maggie. More likely she was the inspiration for the unfortunate Catherine Holly in Suddenly, Last Summer, but without the innocence-or, at least as performed by Elizabeth Taylor, the sheer obliviousness. Maria St. Just was the dick-bait or lure for Tennessee and his friends when they toured Mediterranean beaches, etc. It was her job to meet young guys and size them up (Tennessee was, like so many of us, a size queen); get them drinking and loosened up for the kill, so to speak. And she was very good at it, since she was after all, a bottom-feeder by nature.

Lahr's very successful biography of Joe Orton pictured him as a brilliant playwright brought down by a murderous lover, all of which may be true. At the time of its publication, we were so taken with it we went back and reread Orton's plays. They were inventive and racy for the late Sixties, but somehow they have been tarnished by the passage of time, their vivacity depleted. Perhaps if he had lived he would have gone onto bigger and better things like Tennessee (no pun intended).

Maria, despite her long exposure to the theatre, was not much of an actress, a fact readily conceded by such friends as she had. Once she was cast as Blanche in an off-off-Broadway production of Streetcar; Stanley was played by a sometime lover of Tennessee, Mike Steen, who was not much of an actor either, but he and Maria hated each other. The best moments in that run were when he used the opportunity to rough her up a little more than the stage directions called for.

The night that Tennesse went to see it many in the audience in the small house were aware of the animosity between the two and the audience laughed at decidedly inappropriate moments. Tennessee turned to his guest and said, "My, my, I didn't realize that I had written such a bad play".

Whatever, if for the public good.

BODING WELL



LIFE UPON THE WICKED STAGE

MUSICAL GIFTS OF THE SEASON

f the Christmas season brings about a virtual cessation of theatrical activity, we are compensated by the gifts of music it produces. Since there was no compelling dramatic fare over the past two weekends, I welcomed the opportunity for a change of pace, visiting the Orpheum for only the second time this season to hear the Louisian Philharmonic, venturing into cabaret, and of course indulging in the theatre buff's favorite sport-avidly listening to the spate of new recordings the season brings.

For its "Classics 5" concert, the LPO was conducted by Robert Spano, and it responded to his precise, commanding manner with a high disciplined and rewarding performance of three works in a wide variet of styles. The program opened with an elegant and exhuberant Mozart Symphony No. 39 in E-flat Major, and the orchestra evoked the wit and warmth which ironically was a product of one of the gloomier periods in the composer's life.

The second item of the evening was the sort of thing which often strikes fear into the hearts of conservative local concert-goers-a new work for an instrument not usually deemed a "solo performer" (Some people have still not recovered from Erb's trombone concerto a couple of seasons back). Edgar Meyer's Concerto for Double Bass and Orchestra, with the composer as guest artist, proved to be a crowd pleaser. While it was an exercise in demonstrating the full range of the instru-ment's voice, the concerto did not seem merely an opportunity for virtuoso showi-ness; it had the earthy, low humor and "down-home" feel one might expect from a composer equally at home in the symphony hall and in recordings with Garth Brooks, Kathy Mattea and others of the country set.

The orchestra concluded with a superbly played Sibelius Fifth Symphony, and Spano elicited from the players a proper tone of heroic affirmation(the work was composed partially in response to the rigors of the First World War). In a sense, this work may be relevant to the LPO's current situation—the musicians are heroically persisting against seemingly hostile forces: At the program's inception concert master Wendy Putnam made a quietly emotional appeal for community support for the struggling orchestra. The ensuing musical performance amply demonstrated that the fine ensemble does

indeed deserve more patronage and respect from its audiences.

nother treat of the holiday season is that it brings back native daughter Diane Lala from Cincinatti. And she has brought with her a new cabaret act, which she performs (in spite of a major cold) with her usual charm and brio at the True Brew in the Warehouse district. Miss Lala is not only a vivacious, personable entertainer, she's also a musical-comedy archeologist who seeks out little treasures of song from relatively unknown shows. Her most recent set includes tunes from such obscurities as Smile ("Disneyland"), Working ("Just a Housewife"), One Two Three Four Five (Maury Yeston's beautiful "New Words"), in addition to a healthy dose of Sondheim. When she does take up a standard, she gives it a unique Lala twist: Her rendition of "Do It Again" gives free rein to her comedic

Some of the songs Lala sings are turning up on newly released recordings aimed at the insatiable musical-comedy lovers' market. Unsung Musicals (Varese Sarabande) is a compilation of rare gems from shows which did not survive their pre-Broadway tryouts or closed shortly after opening. It is a must for any theatrephile on your shopping list with its all-star performers and musical rarities. Among its pleasures are the rousing title tune from Sherry, the absolutely politically incorrect "Silverware" from We Take the Town (yes-a musical about Pancho Villa), and a wistful ballad called "Starfish" from the stage version of La Strada.

From the same company comes the "Lost in Boston" series, a collection of songs cut from successful shows usually in order to strengthen the show as a whole, not because the songs were inherently inferior (though material excised from The King and I and West Side Story may be of dubious merit. Often it seems that the music which was cut was better than that which remained. Several numbers from 110 in the Shade give that impression, but perhaps that's because they are performed by the delightful Sally Mayes. Mayes also has a highly recommendable new release on Varese. Our Private World is an entertaining compilation of Comden and Green material.

The late Jule Styne is honored on an RCA Victor recording. Nothing says







THE MOVIE POLICE

COSTUME EPIC

obert Altman is an oldfashioned showman. At his best, in Brewster McCloud and The Long Goodbye and Nashville, he has the audience gasping for breath, amazed at how many characters and plots he can keep in the air at the same time. His movies are elaborate stunts, feats of cinematic prowess-there really should be a barker outside the theatre urging the passers-by to "step right up and see the Amazing Alt-Man, He cuts! He pans! He cranes! He dollies! He tracks! He even shoots a nine-minute scene without so much as a cut!" So breath-taking are his camera moves, so exhilarating his rhythm and tempo, that it can be days before the viewer realizes he or she has been had. For all its innovations in form or structure, Nashville got it all wrong when it came to the South and Southern politics and country music-but you didn't care. As with Woody Allen (and now, I guess, Quentin Tarantino), Hollywood luminaries are willing to work

for scale for Altman and so Nashville was full of highpriced talent having the time of their lives working up quirky character parts. Like an indulgent paterfamilias, Altman encourages their antic behavior. (The glorious exception is Altman's masterpiece, McCabe and Mrs. Miller, the only time the director would get full-bodied performances rather than mannered bits-o-business.)

After Nashville, something happened, something terrible happened. Altman began to take his press seriously and himself too seriously. I couldn't believe it, but I remember stumbling out of

his next movie, the truly execrable Buffalo Bill and the Indians, after a mere forty-five minutes. I felt as if I were in a state of shock—here was my favorite director (at the time) and I was walking out on his latest movie! And then the following year

came Quintet, the gold standard when it comes to worst movies of all time. After that, it was a head-long plunge into-gasp-mediocrity: A Perfect Couple, A Wedding, H.E.A.L.T.H., and his Hollywood swan song, Popeye. One hears

When he was good, Robert Altman made films like Brewster McCloud (1970) with René Auberjonois as the lecturer in ornithology who identifies with his subject to the point of metamorphosis—the scene almost looks it was shot in our favorite store in Paris, Deyrolles—a taxidermist's on the Rue du Bac.

that by this time Altman's fondness for booze and the noxious weed had cost him his facility behind the camera. Certainly, let's hope the likes of Come Back to the Five and Dime, Jimmy Dean, Jimmy Dean and, especially, Fool For Love can be

The rot started to set in with Altman about the time of Buffalo Bill and the Indians or Sitting Bull's History Lesson (1976); Geraldine Chaplin-as sharpshooter Annie Oakley-shows off her virtuosity with a shootin' iron as Buffalo Bill Cody (Paul Newman) and Cody's poor relation Ed (Harvey Keitel, who played smaller roles in those



chalked up to the effects of alcohol poisoning. (Ever since working with Sam Shepard on Fool For Love, Altman never hesitates to badmouth America's most self-indulgent, self-absorbed, selfimportant playwright, a fact that guarantees there'll always be a special place in my heart for Altman.) Then it was self-imposed exile in la belle France, directing operas and a series of movies that practically no one saw (Do you know anyone who's seen O.C. and Stiggs?).

Just when everyone thought that the last had been heard from Bobby Altman, and it was time for the AFI Life Achievement Award, he was "rediscovered" with The Player, a satire on Hollywood and the suits that would no longer hire him. Short Cuts found him straining for significance (a good way to get an artistic hernia) and doing some of his best work since Nashville. Which, finally, brings us to Prêt-à-Porter, or as it has been re-titled at the eleventh hour, Ready To Wear, a putative satire on the fashion industry which, if I may borrow a page from a noted local educator on a work by Truffaut, is like a satire on satire. Surely everyone knows that fashion is not to be taken too seriously and don't tell me I've got to be wrong because Tina Brown devoted an entire issue of The New Yorker to 'couture,' going down on Karl Lagerfeld, Jean-Paul Gaultier, Donna Karan, Ralph Lauren, and that ilk. Altman also knows his subject this time is frivolous and Ready To Wear is probably his most relaxed and playful film since his Nashville days. Aware that you can't

really make an important statement about the human condition with a fashion statement, Altman sets out to have an impish good time at the expense of these silly creatures. He's nasty and gleefully so, and it's nice to see a director so unabashedly go about bashing those who would tell us what we should and shouldn't wear.

No one is likely to mistake Ready To Wear for top-of-the-line Altman, but like slumming it has its pleasures: Kim Basinger as a fashion reporter with a twangy Texas accent who covers the fall collections for TV viewers back home in extravagantly overwrought phrases cranked out by her assistant ("...from supernovas to super-nobodies..."), the three dowager-editresses from the publishing world representing Elle (Linda Hunt, as a woman), British Vogue (ditzy Tracey Ullmann, a vision in an over-sized Mad Hatter chapeau), and Harper's Bazaar (the icky Sally Kellerman, fresh from being the voice of Hidden Valley Ranch's Honey Dijon dressing); Stephen Rea as a wiseass fashion photographer who sets out to humiliate the three.

While Generation-X'ers will probably not be familiar with the-how shall we word it?-more mature actors and actresses, Ready To Wear is a veritable where-are-they-now of art film stars for the baby boomers in the audience. Anouk Aimee is a dignified latter-day incarnation of the beauty in Jacques Demy's Lola, while Sophia Loren and Marcello Mastroianni frequently appear dazed and baffled, not certain what they're doing in

this movie.

As enjoyable as the odd line and the occasional gesture frequently are, you leave the theatre convinced there must have been some essential parts that didn't survive the editing. All the big scenes seem to be missing. Maybe, though, that's the ultimate statement about the world of fashion. A

GAY LEADERS FAIL TO DEAL WITH POLITICAL REALITY

ast month's Republican tidal wave presents our community with the challenge of the decade. Gay Americans are at a crossroads, we can decide to build bridges to the Republican Party or we can continue the fourteen-year history of buming the bridges. It is time for gay leaders to Put away the matches. Gay organizations should stop crying about the election results and deal with today's political facts of life.

It is troubling that the Human Rights
Campaign Fund (HRCF) and the National
Gay and Lesbian Task Force (NGLTF) seem
to be having a hard time accepting that fact
the there is a new political era of Republican
dominance. The Democratic Party accepts the
fact that the Republicans made tremendous
gains across the country, the press accepts that
fact, the American people accept that fact.
Everyone can read the election results but the
HRCF and the NGLTF.

Gay leaders can scream and yell, hoot and holler, and hold their breath until they turn blue. But it will not change the results of the election. Gay leaders can ignore the results of the midterm elections and click their heels three times but it won't change the fact that Democrats got their butts kicked by the American electorate. In Congress, Republicans took control of the US Senate, where they won over a half dozen Democratic seats while no incumbent Republican lost. Republicans took control of the US House after forty-two years, by defeating dozens and dozens of incumbent Democrats while no incumbent Republican lost In January, 30 states with 73% of the nation's population will have Republican Governors.

Tim McFeeley of the HRCF issued a statement that talked about the importance of the victory of Senator Chuck Robb in Virginia. While I, too, was glad to see Robb beat Oliver North, that race was certainly the exception, not the rule. Most HRCF-endorsed Democratic Senate candidates lost; Tom Andrews in Maine, Ann Wynia in Minnesota, Joel Hyatt in Ohio, Alan Wheat in Missouri, and Sam Coppersmith in Arizona. In Vice Presdient Gore's home state of Tennessee, Democrats lost BOTH Senate seats. Bragging about winning the Virginia Senate race is like bragging that you saved the flower arrangements from the Titanic.

A prime example of gay leaders ignoring the real world can be found in a statement by Peri Jude Radeic of the NGLTF. She said that as a result of the elections, gay groups must forge alliances with blacks, women and Hispanics. *Time Out! Reality Check!* It wasn't a black landslide or a women landslide or a Hispanic landslide—it was a Republican landslide. Deal with political reality—the Republicans are a powerful force to be

reckoned with. You can't close your eyes and wish the GOP would go away. For fourteen years, many gay leaders have made a career of Republican-bashing, this habit must be broken.

The Republicans must be educated on gay issues and the needs of gay Americans. Irs going to be hard work, but we have to do it. Yes, Republicans have bigots like Jesse Helms (don't Democrats have Sam Nunn?) But there are also pro-gay Republicans like Massachussetts Governor Bill Weld or Minnesota Governor Arne Carlson or Senator John Chafee from Rhode Island or Connecticut Congressman Chris Shays. We must work to increase both the number and the influence of moderate Republicans.

Gay leaders are worried about the next two years with a Republican Congress. For the last two years, the Democrats had control of Congress and the White House—and what did we get? A gays in the military policy of "don't ask, don't tell"—wow, thanks a lot, Democrats. If you read the GOP's "Contract with America", it does not contain a single word of antigay rhetoric. As a matter of fact, 98% deals with economic matters such as the balanced budget amendment, line-item-veto and welfare reform.

And the terms "right-wing" or "conservative" are not dirty words. Not all gay Americans are liberal Democrats, many hold views on certain issues that might be viewed as conservative. A survey by the Advocate magazine found that 34% of gay voters are not Democrats, but are Republicans and Independents. Gay leaders should stop making "boogey men" out of people who don't pass their own "politically correct" liberal litmus test.

And it's time for gay leaders to address homophobia in both political parties. Since 1980, every other phrase from gay leaders has been "Republican Jesse Helms this or Republican Jesse Helms that". It's time to confront non-supportive Senate Democrats like Kentucky s Wendell Ford, Nebraska's Jim Exon, North Dakota's Byron Dorgan -each has a record on gay issues just as bad as many Republicans. And yes, we all know that GOP Congressman Bob Dornan from California has a zero rating on gay issues as do many Republicans. But so do several Democratic Congressman; Louisiana's Billy Tauzin, Mississippi's Mike Parker, Missouri's Ike Skelton, New York's Michael McNulty, Oklahoma's Bill Brewster, Pennsylvania's Tim Holden, Tennessee's Bob Clement, Texas's Pete Geren, Virginia's Lewis Payne, to name a few

Last month, the American voter sent a loud wake-up call to the nation's political parties. Why are our gay leaders deaf?

HIV REDUCED SOME 92% BY AZT & 3TC

Glasgow, Scotland - The combination of Retrovir brand zidovudine (AZT) and the investigational drug 3TC (lamivudine) reduces by 92 percent the amount of virus in the blood of patients infected with the human irnmunodeficiency virus (HIV), according to a new study. The reduction is much greater than what is seen with any single licensed therapy. Patients receiving the combination experienced an average gain of 85 CD4+ cells after eight weeks in the study and maintained an 80 cell increase at week 24. At week 48, this increase persisted with a 49 cell increase over baseline. Patients who received Retrovir alone over the same period had CD4+ cell counts drop by an average of seven cells at week 24. However, patients in the Retrovir only group who switched to the combination after 24 weeks of study showed an increase of 40 cells above baseline by week 48.

These data show the combination of Retrovir and 3TC to have the most prolonged and pronounced effect of any drug regimen studied to date in suppressing the replication of the virus and boosting the body's own infection-fighting capabilities. These studies assessed laboratory markers of HIV disease; they did not assess clinical endpoints. The data were presented at the Second International Congress on Drug Therapy in HIV infection by the French research team which coordinated the trial. "These data are extremely significant not only for their effectiveness in reducing virus and increasing CD4+ cell levels, but also because these effects persisted throughout the year-long study," said Dr. Christina Katlama, the leader of the study who presented the data. "It's also important to note that the combination was very well tolerated by patients.'

The double-blind study randomized 129 patients to either Retrovir and 3TC combination or the control regimen of Retrovir alone Patients in the combination arm received 300 m8 Of 3TC twice daily and 200 m8 of Retrovir three tirnes daily. Nausea, vomiting and headache were the most commonly reported adverse events. Patients admitted to the study had CD4+ cell counts between 100 and 400 and had less than four weeks of prior therapy with Retrovir. The findings are consistent with a second study presented by Dr. Schlomo Staszewski from Frankfurt, Germany, which showed that in patients already treated with Retrovir for at least 24 weeks, the addition of 3TC produced significant improvement in immune response. When compared with other two drug combinations, Retrovir and 3TC is the most effective regimen studied to date, including Retrovir and ddl or Retrovir and ddC.

Researchers theorize that 3TC may play a key role in preventing the development of viral resistance to Retrovir, thereby increasing the duration of the proven antiviral effect of Retrovir. The combination does not prevent the rapid development of resistance to 3TC. These data are precursor to the presentation of clinical trial data on two U. S studies of the Retrovir and 3TC combination which will be shared in early 1995.

Dr. Margaret Fischl of the University of Miami School of Medicine presented data which indicate that combination therapies with nucleoside analogues, including Retrovir, ddl and ddC, are more effective in increasing CD4+ cell counts and for longer periods of time than therapy with a single agent. In addition, she reported that the combination of Retrovir, ddI and Nevirapine, a non-nucleoside reverse transcriptase inhibitor, also appeared to result in more pronounced effects.


Retrovir, widely considered to be the cornerstone therapy in almost all two and three drug combinations, was the first drug released for marketing for the treatment of HIV infection and AIDS. Its use as a therapy for HIV infection and AIDS was discovered by scientists at Burroughs Wellcome Company which produces and markets the drug.

3TC is licensed by BioChem Pharma to Glaxo Pharmaceuticals. The Retrovir and 3TC studies were funded by Glaxo. InMarch 1994, Wellcome and Glaxo signed non-legally binding agreements giving Wellcome the option to develop 3TC for HIV infection. Glaxo has informed Wellcome that it has decided not to proceed with this option. Δ

TENNESSEE'S SODOMY LAW POSSIBLY UNCONSTITUTIONAL, SAYS JUDGE

A county judge in Tennessee this week declared that the state's law prohibiting consensual sodomy violates a state constitutional guarantee to the right of privacy. The ruling came in a Dec. 7 preliminary hearing in which the judge refused to grant the state's request that the lawsuit challenging the sodomy law be dismissed.

Instead, Judge Walter Kurtz of the Davidson County Circuit, which includes the state's capital of Nashville, issued a twenty-page memorandum, saying that the state could not prohibit same-sex acts simply because the majority thinks it immoral. Lesbian activist attorney Abby Rubenfeld, who organized the challenge, said yesterday that she is "cautiously optimistic" that Kurtz's ruling will lead the state Supreme Court to strike the law from the books. Rubenfeld said the judge had scheduled a trial date of Janu 10 to hear evidence in the case but that the state's attorneys have not indicated they play of oring any witnesses to justify the law. Instead, she said, the state tried to justify the law by saying that the law protects the public health. But Judge Kurtz said the state had failed to provide any evidence to support that

After Kurtz issued his memorandum Wednesday, Rubenfeld filed a motion for summary judgment. She said the state has 30 days in which to reply to that motion and that, then, Judge Kurtz could choose to issue a final declaration without going to trial. Once Kurtz issues his final ruling, the case will go directly to the state Supreme Court.

If Tennessee's law bites the dust, it will represent the seventh state law prohibiting sodomy to be either repealed, overturned, or gutted since 1986, when the U.S. Supreme Court ruled, in Bowers v. Hardwick, that Georgia could prohibit consensual same-sex sodomy in the privacy of the home. That would leave only eighteen states with enforceable sodomy laws still on the

books. The Tennessee case, Campbell v. Tennessee, is being pressed by five plaintiffs-Nashville Lesbian activist Penny Campbell and four others, including an airline pilot and a nurse. Their lawsuit charged that the law violates their rights to equal protection and privacy under the state constitution. The Tennessee sodomy law prohibits sodomy only by same-sex partners, not heterosexual ones. The state's sodomy law prohibited both samesex and heterosexual sodomy until 1989, when it revised the law to prohibit only same-sex acts.

In reasoning that Tennessee's sodomy law is unconstitutional, Judge Kurtz took a slap at the U.S. Supreme Court majority opinion in Hardwick. Instead, he recalled the minority's dissent as emphasizing that the record in the case was "devoid of any evidence which indicated that sodomy had adverse consequences for the general public health or welfare such as spreading communicable diseases or fostering other criminal activities." Justice Harry Blackmun (the Nixon appointee who wrote the minority dissent), noted Kurtz, "concluded that the belief that homosexuals do not share the majority's values does not justify invading the homes, hearts and minds of homosexuals ...

"It is inconsistent with the state constitutional right of privacy and liberty to prohibit behavior based on majoritarian morality," wrote Kurtz. The right to privacy, he said, "is a right of independence in making certain important personal decisions with the ability to conduct oneself in accordance with those decisions, undeterred by governmental restraint. This right includes the right of sexual expression with another consenting adult regardless of the gender of the sex partner." (Lisa Keen, Washington Blade) ∆

AN ATTEMPT AT LESBIAN DOUBLE SUICIDE IN CHINA

CHINA-Two lesbian lovers agreed to commit suicide after arguing over whether or not one should enter a heterosexual marriage (unlike the classic example in the famous Japanese bunraku, Double Suicide in which caste is more involved and one of the lovers is

According to United Press International, on Dec 5, the Shanghai Evening News reported that the two women became lovers years ago after meeting each other while working for the same company in Suihua, a city in the northern Heilongjiang Province. The younger of the two women, who were both in their early 20s, decided to enter a heterosexual marriage while the other vehemently opposed the idea. The two agreed to commit suicide by injecting each other with lethal doses of the disinfectant Lysol, which seems like an ugly way to go. One woman died and the other remains in critical condition.

The UPI report stated that the Chinese press rarely deals with homosexual matters but that tabloids and a new crop of penny-dreadfuls in the 'boom cities' of southern China, including Shanghai, "are offering a steamier fare of gossip, romance, and crimes of passion." Just what China needs-its own 'yellow journalism.' (Washington Blade) A

SURPRISE BUSINESS NEWS OF THE MONTH

A Federal appeals court ruled November 22 that the pharmaceutical company Burroughs Wellcome has exclusive rights to market the anti-HIV drug AZT (zidovudine). The U.S. Court of Appeals for the Federal Circuit upheld a July 1993 district court ruling on five of six disputed AZT patents, ruling that two scientists from the National Institutes of Health did not contribute significantly to the invention and development of AZT. The sixth patent claim was sent back to the district court to determine the facts. The decision rejected the claims of two other drug companies, Barr Laboratories, Inc. and Novopharm Ltd., and prevents these companies from marketing a generic version of AZT under a license granted by NIH, which conducted preliminary testing of the drug. Burroughs Wellcome put AZT on the market in 1987, using the brand name Retrovir. This, of course, means also that Burroughs Wellcome can continue to sharkishly manipulate drug prices-that of AZT is, in particular, notorious for its artificial inflation, and operate with the impunity of monopoly. Why is this news seem so depressingly, malodorously stale? Δ

MELINDA PARAS NAMED EXECUTIVE DIRECTOR OF NGLTF

The Board of the National Gay and Lesbian Task Force (NGLTF) announced the appointment of San Francisco Health Commissioner Melinda Paras as the new executive director of the organization, which has been newly re-shaped following a four-month program evaluation of the agency. Appointed to the San Francisco Health Commission in 1993 by Mayor Frank Jordan, Paras chairs the Budget Committee and serves on the Joint Conference for San Francisco General Hospital.

For the past four months, Paras has headed a transition team at NGLTF, assessing the organization's strengths, challenges and duties, and developing a plan for its next two years. The NGLTF board established the transition team in response to the departure of several key staff people, the changing demands of NGLTF's

constituents and the altered political atmosphere facing the gay and lesbian community. Following extensive evaluation, Paras has created "a new vision for a new era."

In addition to heading the transition team onsible for creating the new structure for NGLTF Paras has assisted in stabilizing NGLTF's finances. The organization had scaled back its budget to 2.6 million dollars and had prepared for a potential year-end deficit following income shortfalls earlier in the year. In her four months as interim Chief Operating Officer, Paras has eliminated that projected deficit and the organization plans to end on the targeted budget.

"I have been a great admirer of NGLTF for ars," Paras said. "I am proud to have led NGLTF out of its internal crisis so it could resume the critical work it does. Our constituents need so much from us-and the re-engineered NGLTF will be in a better position than ever before to deliver relevant programs and resources to our community

Paras has been active in movements for social change in the Filipino and lesbian/gay communities for more than 20 years. In San Francisco, she served as coordinator of the lesbian/gay speakers bureau of the Community United Against Violence anti-violence project; vice president of the Harvey Milk Lesbian/Gay Democratic Club; staff member of the 1990 and 1991 political campaigns for domestic partners legislation in the city; and campaign manager for the successful campaign to defend the new domestic partner law in 1992. She pioneered efforts to make AIDS services available to poor and disenfranchised communities as the Director of Multicultural Affairs and later as the Deputy Director of the somewhat beleaguered Shanti Project, a large AIDS service provider in San Francisco. CLINTON NAMES FLEMING AS NEW AIDS "TSAR"

Acting director of AIDS policy Patricia Fleming was appointed Nov. 10 to permanently replace former AIDS tsar Kristine Gebbie, who resigned from the post in June. Fleming, a former assistant to the Secretary of Health and Human Services, has been acting director since Gebbie resigned amid criticism that her leadership was ineffectual. Fleming said her chief mission will be to shape the AIDS budget and see it through the necessary steps to approval, as well as serving as the president's liaison to HIV-impacted community. In an interview with the New York Times, Fleming, who is African-American, said President Clinton has requested a report on AIDS in

Fleming is particularly concerned with rising AIDS rates in women and minorities, and wants to devote more work to vaginal microbicides and female-controlled safe-sex devices. She has advocated abstinence and monogamy as the best ways for teens to avoid contracting HIV, noting that half of all HIV-infections occur before the age of 25. She also has the support of the AIDS Action Council and the National Minority AIDS Council, ACT UP has criticized the president for appointing a mid-level official to the job and not making the post a cabinet position. 



FORMER COACH SAYS SEXUAL ORIENTATION LED TO HER DISMISSAL

columbia, Ky. (AP)—Many Lindsey Wilson College volleyball and softball players coached by a woman who says she was fired because she is a lesbian say the coach's personal life was never an issue for them. The players are expressing outrage at Diana Chalfant's firing. They say they never thought about Chalfant's personal life. "Number one, she never told any of us she was a lesbian or ever commented on it. It was not an issue," said Melissa Schultz, 19, a sophomore volleyball player from Campbell County. "It didn't matter. It wasn't an issue.....If they did fire her because she's a lesbian, that's just not gight"

Chalfant was preparing the women's softball team for its first fast-pitch season this spring when she was fired Dec. 9 by Ray Wells, athletic director of the private, liberal-arts college affiliated with the United Methodist Church. "When we found out, we were shocked that this could happen," said Sonya Mouser, 19, a freshman from Nelson County. Chalfant said Wells told her he didn't like her handling of the volleyball program, although the team had just finished a winning season. Wells also said there had been "some lesbian incidents," Chalfant said. Chalfant, 30, acknowledges that she is gay, but said she was not open about it on campus and never made advances toward any of her players. Wells and college President John B. Begley declined last week to talk about Chalfant's firing. They cited a school policy that forbids publicly discussing personnel matters. "She was a fine coach," Begley said. "All personnel decisions are hard to make, and it was particularly hard with Diana." Begley said the school must follow the lead of the church, including its social principles, and the Methodist church does not condone homosexuality and considers it incompatible with the Christian faith,

This is such an amazing and arrogant piece of nonsense we feel it incumbent to editorialize: First, when will Tafel and the other Republicans, and Democrats for that matter, realize the way things are set up in this country? As Adam Gopnik recently pointed out in The New Yorker, the United States is politically Republican and culturally Democrat and has been for some time, but neither party is, or ever will be, happy. The Republican desire to influence the cultural climate borders on frenzied lust, as does the Democratic urge for political control. In all probability, this won't happen. Second, why must Tafel (like those horrid-but-amusing NeoCon intellectuals) blame the Sixties for everything? Was this guy even alive then? Doesn't he realize that those of us who lived through the Sixties and are not Neo-or-Paleo-Cons view the period as Talleyrand did the ancien régime, "Only those who lived before the Revolution know how sweet life could be"? Third, why must pioneering leaders be "repudiated"? It's unusually Freudian to think that the achievements of the parent must be negated, indeed destroyed, denied, so that the children can progress unimpeded and unrepressed. Fourth, does this popinjay really think he speaks for more than a handful of little guppie cloak-and-suit megalomaniacs who are ecstatic, to the point of incoherent mean-spiritedness, and drunk with the thrills of prospective sycophancy and political table scraps. All that ass-sucking might really pay off this time.

Begley said.
Chalfant said Wells fired her after first asking her to resign quietly. When she asked for a detailed explanation, he wouldn't give one, she said. Later that

day, Chalfant met with Begley, but he also offered few details, she said. "It was, 'Get off campus, get your stuff out of your office [for this "fine coach"], and we don't want to see you," she said last

week. "It was awful."

There are no Kentucky or federal laws prohibiting discrimination based on sexual orientation. Because such discrimination doesn't violate the law, attorneys rarely file lawsuits challenging dismissals such as Chalfant's.

Nonetheless, she said she wants to sue. Δ

OUT-OF-COURT SETTLEMENT REACHED IN PRIEST-HIV LAWSUIT

DENVER (AP) -An out-of-court confidential settlement has been reached in a lawsuit filed against a Catholic priest by a man who alleged the priest molested him for two decades and gave him an HIV infection. Thomas Perea, 38, a substitute teacher in Boulder, sued the Rev. Delbert Blong and the Pueblo Catholic Diocese last year, a sexual relationship with the priest from 1971 until late 1992. He alleged the priest infected him with HIV. The Rev. Edward Nunoz, Pueblo Diocese vicar general, said December 15 the diocese admitted no wrongdoing in the settlement reached last week. All parties agreed not to disclose terms of the settlement.


Perea said he learned he had HIV in March 1993. His suit alleged the diocese knew of Blong's activities, but did nothing. Blong, 68, admitted the sexual relationship with Perea. The priest also said he had learned last year that he had AIDS. Pueblo Bishop Arthur Tafoya prohibited Blong from performing sacramental duties. Blong, who served his entire priesthood in the Pueblo Diocese, lives in the Denver area. Tafoya has said the diocese was surprised about the Blong-Perea relationship.

Perea alleged Blong first molested him

when he was 15, and insisted that protection was unnecessary because he was monogamous. Blong later admitted he had sex with four other men, all of whom were infected with HIV and two of whom later died of AIDS, Perea alleged. Blong denied the allegation. He said he learned he had AIDS in January 1993 when he was hospitalized for salmonella poisoning and heart surgery. Perea contended he used protection with his other male lovers, all of whom tested negative for HIV. Δ
